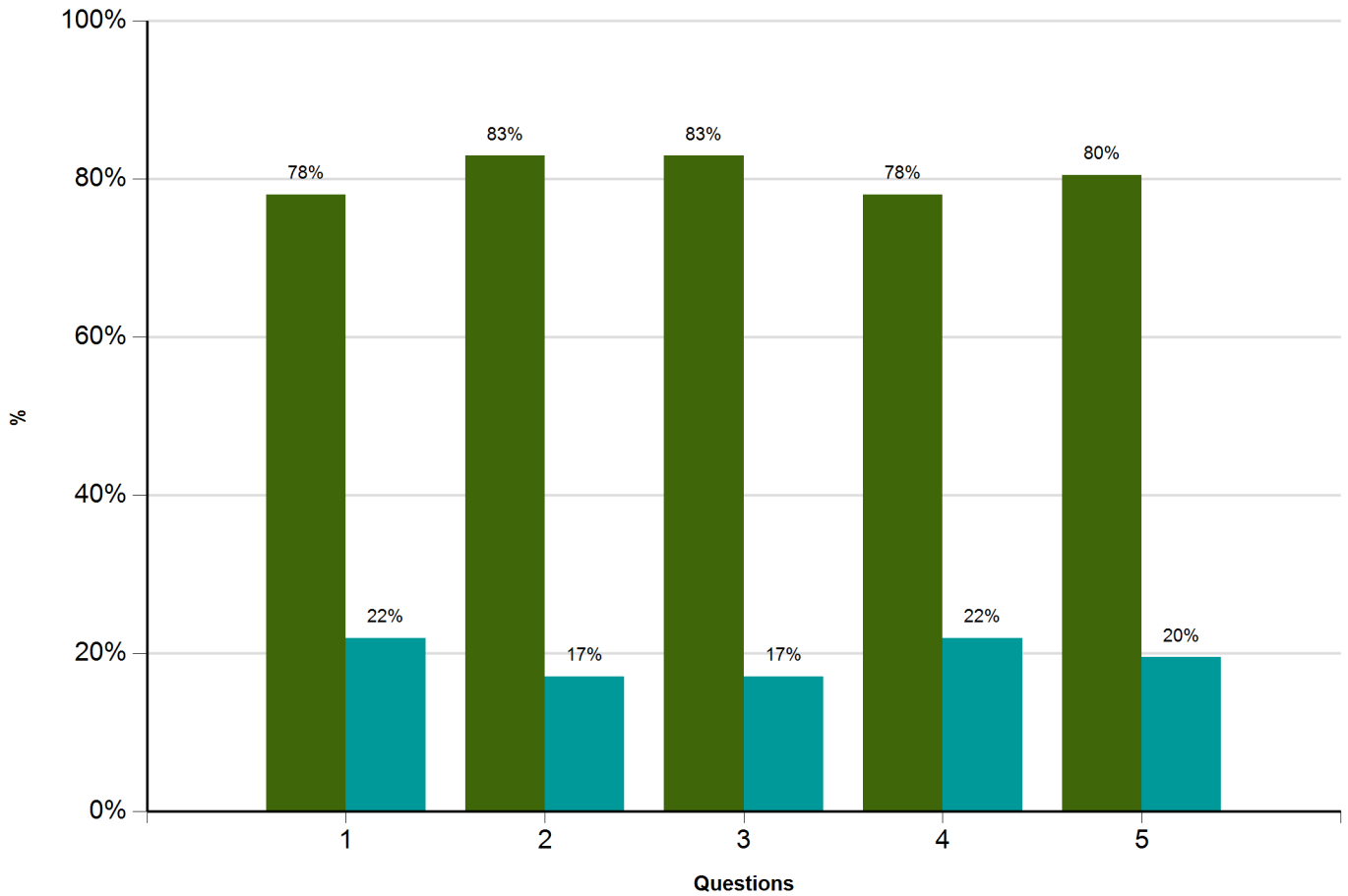

6 What aspects of the program will be most useful?* (Maximum 2000 characters)

- * Understanding why people with a diagnosis of ASD behave they way they do. Different strategies to put in place when working with kids with ASD.
- * The very practical solutions to behaviours we want to divert or avoid will be the most useful aspect of the program. Sue Larkey gave very clear instructions on how to address a wide range of issues and I have already implemented them across the classrooms I teach in at the school.
The following is a list of the most useful aspects I got from this PL- although I learned a great deal more than this:
Always say their name before an instruction, otherwise they won't know that you are talking to them.
Delayed response time. Give the student ten seconds at least to process the instruction or question before they respond to you. They are not being naughty or ignoring you. It just takes that long to process and respond.
Always instruct them on what to do not what not to do.
Ladies and any men with lighter, higher voices, please try to use a monotone, lower voice and keep it calm:
Use simple instructions. Don't ramble or be conversational while giving instructions.
Do not suddenly interrupt class during an activity that is already underway to add further instructions. This disruption can halt any work from the student altogether.
Provide the pencil, the workbook, spare paper, any tools the student needs the teacher can hand directly to them.
You can't get rid of a behaviour, you can only replace the behaviour with another one. The teacher can choose the behaviour. Refer to the Sue Larkey behaviour books.
Limit choices. Choosing a free time activity can be stressful and may lead to unexpected choices.
- * I have found all five parts extremely important and useful. I particularly have found the session discussing girls and ASD of high interest.
- * The knowledge gained regarding how to effectively teach students on the spectrum was invaluable and provided me with strategies that I will definitely implement.
- * Practical strategies for dealing with autism in the classroom and in 1:1 teaching episodes. Insights into the way to ensure there is inclusion in the classroom.
- * The depth of understanding of ASD students and strategies to optimise thei learning capabilities.
- * Strategies to use in the classroom
- * Sue Larkey gave extremely valuable and helpful tips in her video series. The five hour course gave specific and practical examples of strategies that are best suited to ASD kids. All teachers should be aware of how to best educate and cater for all students in their care.
- * Strategies I could realistically implement.
- * The printouts of the slide information, readings and the different strategies that were talked about were the most useful parts of the program.
- * It helped me to understand that ASD has an individual nature. All children with ASD are different. Strategies that may work for one child will not work for another. Also, strategies wear out and need to be changed.
- * The large range of strategies to try. I know not every one of the strategies will work for every child but I think it is really important to try them to find out which ones will work. It was useful to have the printed handout.
- * The most useful part of the program was the variety of strategies provided and the explanation of the difference between tantrums and meltdowns.
- * a refresh of ideas to assist all students particularly those with ASD to maintain strong connections to learning
- * Classroom strategies
- * The information that Sue gave helped me understand why certain students exhibit certain behaviours, and what these behaviours mean. I was provided with information on how to deal with behaviour, how to tailor education, how to support their learning, and just overall understand each child.

6 What aspects of the program will be most useful?* (Maximum 2000 characters)

- * The most useful aspects of the program were the strategies to help children with ASD flourish in the classroom. One aspect that stood out for me was how children with ASD like 'old school' learning styles, particularly because I find my teaching is very modern. For example having the same routine every day helps children with ASD's anxiety. A Monday morning might include the same routines of handwriting, weekend recount etc, in a booklet that looks the same every Monday. So when the child enters the classroom they know exactly what to do and there is limited surprise.
- * The Course outline and resources as a reference for later planning and development.
The online nature and flexibility of timing and delivery of the course made it very accessible
- * The strategies for assisting students with ASD within the classroom.
- * practical strategies to use in class.
- * A better understanding of ASD students and their needs.
- * The wonderful, practical strategies that were provided to support students with ASD is certainly the most useful aspect of this PL that I will take away from it.
It is not just the list of strategies but the reasoning behind each one and the 'how to' to ensure success, that was clearly articulated and very easy to implement.
The PL also provided quality reading, audio and visual resources to back up, maintain and as go to support to clarify or provide further help in the future.
- * What I found most useful was not only did it provide useful and practical solutions when teaching a student with ASD, it provided a clear and easy to understand insight into the world of a student with ASD. It also provided further readings and resources to help build our knowledge and skills, as well as improve our teaching practice.
- * This online program was highly engaging and provided deep knowledge and understanding of ASD.
Each lesson had a clear focus and were sequential.
The presenter, Sue Larkey, provided first-hand experiences to explain ASD and the implementation of strategies to support these students.
Notes from each lesson could be downloaded.
- * The resources (I have since purchased some for the school) the language we have discussed using this language consistently with staff, the ideas- short, sharp and concise
- * I enjoyed how Sue related scenarios for a child on the spectrum to us (adults) as it created a window into how they think, act and feel. During the PL we were exposed to a huge range of strategies whether it be verbal, visual or concrete to assist in the classroom.
- * This PL will support me in my endeavors to improve my teaching when dealing with students on the autism spectrum. I now understand how they comprehend the world they live in and appreciate the factors that can cause them to behave in what may be perceived as socially unacceptable.
I also acknowledge how important consistent practices are when dealing with these students and recognize the necessity for school and home environments to communicate frequently. Mainly to ensure that the same strategies and management practices are utilized and changes to routines are kept to a minimum. environments.
- * The range of practical strategies offered through the PL to support the inclusion and learning of students on the autism spectrum. In particular the emphasis on understanding each student's learning needs and interests and ways to modify the environment (Eg. use of routines, visual time tables, sensory objects and rewards) and encourage students to regulate their emotions.
- * The course gave me new strategies to work with the children I work with. It also reminded me of strategies I have not used for a while.
- * The importance of monitoring the behaviour and triggers of children with ASD and how to prevent meltdowns and what strategies and tools that are useful. Knowing that all ASD children are not the same.
- * There was a great deal of content in the 5 webinars. The most helpful was the overall understanding Sue was able to express in the 5 hours. some of these include:
The "be a GPS" description
The impact their cognitive ability has on their learning
The impact their process and memory has on how content to be learnt needs to be delivered.
The repetition needed to ensure learning becomes imbedded in long term memory.

6 What aspects of the program will be most useful?* (Maximum 2000 characters)

- * All of it was extremely useful. It was clearly presented in a way that was very easy to follow.

I know Sue Larkey has lots of books for sale... but I wouldn't know which one to begin with. Luckily my school has agreed to buy several of them.
